Job description

A footballer plays football professionally in competitions.

Occupations considered suitable under this ANZSCO code:

- > Australian Rules Footballer
- > Rugby League Footballer
- > Rugby Union Footballer
- > Soccer Player

These occupations are classified elsewhere in ANZSCO or are not at the required skill level.


Footballer is a VETASSESS Group D occupation

This occupation requires a qualification assessed as comparable to the educational level of an Australian Qualifications Framework (AQF) Certificate III or IV with appropriate duration of relevant employment duration.

Applicants can fulfil the assessment criteria for this occupation in one of four ways.

Qualification and employment criteria

Applicants must have fulfilled at least one of the following four criteria (1-4):



 * Highly relevant paid employment duration (20 hours or more per week)

Pathways 1–3

minimum years of post-qualification employment highly relevant to the nominated occupation, completed at an appropriate skill level in the five years before the date of application for a Skills Assessment.

Pathway 4

minimum 4 years of relevant employment required – Three years of relevant employment (can be outside the last 5-year period) in addition to at least one year of highly relevant employment within the last five years before applying.

A positive assessment of both qualification level and employment duration is required for a positive Skills Assessment outcome.



Qualification

This occupation requires a qualification assessed as comparable to the education level of an Australian Qualifications Framework (AQF) Certificate III or higher and in a field highly relevant to the nominated occupation.

Highly relevant major fields of study include:

> Sport - Football.

Employment Tasks

Highly relevant tasks include, but are not limited to:

- > Maintaining a high degree of expertise in football
- Attending regular practice sessions and undertaking private training to maintain the required standard of fitness
- > Deciding on strategies in consultation with coaches
- > Assessing other competitors and conditions at venues
- > Competing in sporting events
- > Adhering to the rules and regulations associated with football.

In relation to professionally practising the occupation in Australia, additional accreditation requirements may apply.
