Job description

A golfer plays golf professionally in tournaments or as a resident professional, and organises golf-related activities.












Golfer is a VETASSESS Group D occupation

This occupation requires a qualification assessed as comparable to the educational level of an Australian Qualifications Framework (AQF) Certificate III or IV.

Applicants can fulfil the assessment criteria for this occupation in one of four ways.

Qualification and employment criteria

Applicants must have fulfilled at least one of the following four criteria (1– 4):

* Highly relevant paid employment duration (20 hours or more per week)

Pathways 1–3

minimum years of post-qualification employment highly relevant to the nominated occupation, completed at an appropriate skill level in the five years before the date of application for a Skills Assessment.

Pathway 4

minimum 4 years of relevant employment required – Three years of relevant employment (can be outside the last 5-year period) in addition to at least one year of highly relevant employment within the last five years before applying.

A positive assessment of both qualification level and employment duration is required for a positive Skills Assessment outcome.

Qualification

This occupation requires a qualification assessed as comparable to the education level of an Australian Qualifications Framework (AQF) Certificate III or higher and in a field highly relevant to the nominated occupation. This includes qualifications assessed at AQF Certificate III, Certificate IV, Diploma, Advanced Diploma, Associate Degree, Bachelor Degree, Graduate Diploma, Master and Doctoral level.

Highly relevant major fields of study include:

- Golf Studies
- Sport, Fitness and Recreation Training Package.

Employment Tasks

Highly relevant tasks include, but are not limited to:

- 1 Plays golf in tournaments for prize money
- 2 Trains in the skills and techniques required for playing golf
- 3 Organises competitions, collects green fees and hires out golfing equipment
- 4 Coaches and instructs golf players by demonstrating techniques
- 5 Oversees training and evaluates golf players' physical condition
- 6 Prescribes routines and corrective exercises to strengthen muscles and improve fitness
- 7 Operates golf related retail operations.
